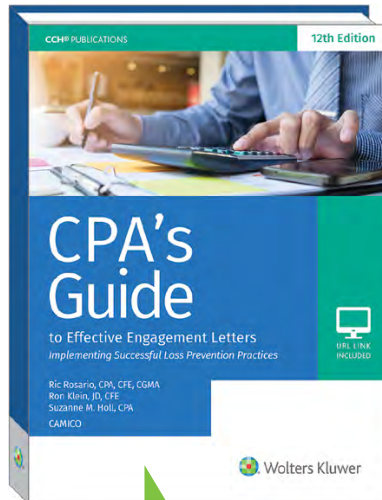

The suggested wording sections are formatted so that the left-hand column contains suggested engagement letter wording pertaining to a specific subject and the right-hand column offers commentary and important advice. The book has been compiled and edited with resources from CAMICO, and the commentary, including pitfalls to avoid, is based on the experience of actual CPAs.
